# Baw Baw Shire Council Rural Recreation Reserve Master Plans - Stage 2



## Project Background and Objectives

Baw Baw Shire Council has commissioned the development of Rural Recreation Reserve Master Plans for Darnum, Longwarry, Thorpdale and Willow Grove Reserves.

The Master Planning process is a continuation of the Rural Recreation Reserve Master Plans Stage 1 project (master plans completed in 2014 for Athlone, Buln Buln, Ellinbank, Hallora, Jindivick, Neerim South and Erica/Rawson Reserves) and will help guide Council's future planning, provision and enhancement of sports and community infrastructure at each of the four sites over the next 10 years. The Final Master Plans will provide a clear vision for each of the recreation reserves and will be used as key planning and implementation documents for both government and community stakeholders.

With increasing demand for improved sport and recreational opportunities and amenities by local sporting clubs, peak sporting associations and community groups, the Master Plan process will seek to address current gaps in sports specific facility requirements. Change room areas, amenities, umpire's rooms, first aid facilities and improving facility accessibility will be reviewed with the key objective to increase participation opportunities for the local community.

Critical to the success of the project will be the identification and assessment of both formal and informal sport and recreation needs to ensure a collaborative approach to the future planning, design and management of local sport and recreation facilities.

# **Project Consultants**

Baw Baw Shire Council has engaged leading sports consultant, *insideEDGE* Sport and Leisure Planning to undertake Stage 2 of the Master Plan process.

insideEDGE is a consulting firm based in Melbourne who have developed a number of state and regional facility Master Plans for government and state sporting associations and have recently completed facility projects with AFL, Cricket and Netball Victoria.

In addition to their own sports facility master planning and management experience, *insideEDGE* will be working with experienced landscape architects, ACLA Consultants who will be responsible for master plan concept design works. Both businesses have significant experience within their specialist fields and have completed a range of similar projects for Councils throughout metropolitan Melbourne, regional Victoria and South Australia.

# **Project Management**

A Project Working Group has been developed to guide project direction, communication and consultation strategies. The Project Working Group will assist the *insideEDGE* in managing project milestones, communications and consultation processes, as well as being responsible for approving project recommendations and reporting outputs.

## **Project Approach**

The Rural Recreation Reserve Master Plans Stage 2 project will be undertaken in five key stages and is scheduled to be delivered in May 2016. The following diagram outlines the key tasks and timelines to be delivered during each stage.
