If you currently hold an eligible Government issued pension card you are entitled to a 50 per cent reduction in registration fees (excluding Declared Menacing, Declared Dangerous and Restricted Breed dogs). Please present your card in person at the time of payment.

Permits may need to be obtained to keep more than two dogs and/or two cats.

State Government Levy

Your animal registration fees include the State Government Levy of \$4.39 per dog or cat registered. The payments are used by State Government to promote responsible pet ownership, administer the Domestic Animals Act 1994, support animal welfare and conduct research into domestic animal management.

Replacement registration tag

Replacement registration tags can be obtained from any Customer Service Centre free of charge.
